WATERMAIN FLUSHING—MAY 13 & 14

It's time to give our water system a spring cleaning! On May 13 & 14, you might notice some cloudy or discoloured water & a little drop in pressure while crews flush the lines. Don't worry—it's normal & temporary!

A few helpful tips:

- Limit water use on those days between 8am—4pm
- Fill a few jugs of water beforehand for drinking & cooking, just in case
- If your water looks off, run your cold tap until it clears

DUST CONTROL—Week of May 12-16

It's that time of year when the roads kick up a little too much & we bring things back under control. Dust control is tentatively scheduled for the week of May 12-16, weather permitting. Our grader will be out beforehand to smooth out the roads, so everything's ready for treatment.

Know the Standard Watering Restrictions!

While we're all ready to enjoy the sunshine, it's also the perfect time to talk about **water conservation**, and remind everyone about our Outdoor Water Usage Bylaw—a key rule to help us all manage our water usage from **MAY to OCTOBER**.

This Bylaw is in place to help us all use water wisely, especially during those hot, dry months when it's needed the most. Most of us take the water we use every day for granted. We turn on the tap and as long as plenty of clean, clear water flows from the faucet, we do not give water much thought.

Despite the little consideration we give it, water is probably our most precious resource.

Here's why these restrictions are so important:

- ⇒ **Why May to October?** - These are the **driest months** of the year, and our water supply can become strained with everyone using more water. The restrictions help ensure we have enough water for everyone, including essential needs like drinking, firefighting, and other critical services.
- ⇒ **Efficient Watering**—There are **designated watering days and times** to make sure we're not wasting water during the hottest times of the day. Keep your plants hydrated but be mindful of the times when it's most efficient!
- ⇒ **Use Water Wisely**—Avoid using sprinklers or hoses when not needed. Instead, try watering early in the morning or late in the evening, when the water stays where it's needed and doesn't evaporate.
- ⇒ **The Bigger Picture**—Water conservation is crucial for protecting our environment, maintaining a stable water supply for all, and keeping our community sustainable in the long run.

As temperatures rise, let's all do our part to make sure we're **smart about water usage** & ready for summer fun!
