

## **BYLAW NO. 8/01**

### **A BYLAW OF THE VILLAGE OF BUENA VISTA TO PROVIDE FOR THE ERECTION OF TRAFFIC SIGNS**

---

The Council of the Village of Buena Vista, in the Province of Saskatchewan, enacts as follows:

1. The following streets are hereby designated as "**STOP**" Streets:
  - (1) Access road from #54 Highway to its intersection with Grand Avenue
  - (2) Grand Avenue from intersection with the access road to #54 Highway westerly to Ninth Street
  - (3) Little Grand Avenue at its intersection with Grand Avenue north of Lot 4, Block 14, plan 71R18842
  - (4) The southeast corner of Hillside Road at its intersection with Grand Avenue
  - (5) The Northwest corner of Pleasant Avenue at its intersection with Grand Avenue
  - (6) The northwest corner of Grand Avenue being at its intersection with the northern extreme of Sixteenth Street in the Town of Regina Beach
  - (7) The northeast corner of Little Grand Avenue at its intersection with Sixteenth Street in the Town of Regina Beach
  - (8) The northeast corner of Woodland Avenue at its intersection with Sixteenth Street in the Town of Regina Beach
  - (9) The northeast corner of Grand Avenue at its intersection with 10<sup>th</sup> Street
  - (10) The southwest corner of Grand Avenue at its intersection with 10<sup>th</sup> Street
  - (11) The southwest corner of Pleasant Avenue at its intersection with Second Street
  - (12) The northeast corner of Grand Avenue at its intersection with 6<sup>th</sup> Street
  - (13) The southwest corner of Grand Avenue at its intersection with 6<sup>th</sup> Street
  - (14) The northeast corner of Highwood Avenue at its intersection with 10<sup>th</sup> Street
  - (15) The southwest side of Highwood Avenue being north of Municipal Reserve 1, Plan 89R70332, at its intersection with 10<sup>th</sup> Street
  - (16) The southwest corner of Grand Avenue at its intersection with Hillside Road

- (17) The northeast corner of Park Place at its intersection with Lakeview Crescent
- (18) The Northeast corner of Highwood Avenue at its intersection with Grand Avenue
- (19) The Southwest corner of Grand Avenue as it intersects with Shady Lane
- (20) The Southeast corner of Shady Lane as it intersects with Grand Avenue
- (21) The North side of Grand Avenue perpendicular to the southeast corner of Shady Lane and adjacent to Lot 4, Block D, Plan FZ5674

2. The following streets are hereby designated as "**ONE WAY**" Streets:

- (1) Shady Lane shall be a one way street for eastbound traffic only
- (2) Lakeview Crescent shall be a one way street for northbound traffic only to its intersection with Buena Vista Bay for the months of November 1 to April 1 of each year.


3. The following streets shall be designated "**YIELD**" Streets:

- (1) Highwood Avenue to its intersection with access road to #54 Highway
- (2) The southwest corner of Fourth Street to its intersection with Grand Avenue
- (3) The intersection located at the southwest quarter of Section 14-21-22-W2nd, abutting the SE ¼ 15-21-22-W2nd to the West, and abutting the NW ¼ 11-21-22-W2nd to the South and facing traffic from the North
- (4) The northeast corner of Pleasant Avenue at its intersection with 2<sup>nd</sup> street
- (5) The southeast corner of 10<sup>th</sup> Street at its intersection with Lakeview Crescent
- (6) The southwest corner of First Street at its intersection with Grand Avenue
- (7) The Southwest corner of Second Street at its intersection with Grand Avenue
- (8) The Southwest corner of Third Street at its intersection with Grand Avenue
- (9) The Southwest corner of Fifth Street at its intersection with Grand Avenue
- (10) The Southwest corner of Eighth Street at its intersection with Grand Avenue
- (11) The Southwest corner of Ninth Street at its intersection with Grand Avenue

- (12) the Northeast corner of First Street at its intersection with Grand Avenue
  - (13) The Northeast corner of Second Street at its intersection with Grand Avenue
  - (14) The Northeast corner of Third Street at its intersection with Grand Avenue
  - (15) The Northeast corner of Woodland Bay at its intersection with Grand Avenue being west of Lot 1, Block 29, Plan 84R18410
  - (16) The Northeast corner of Woodland Bay at its intersection with Grand Avenue being west of R2, Plan DM2190
  - (17) The Northeast corner of Shady Lane at its intersection with Grand Avenue
  - (18) The Southwest corner of Lakeview Crescent at its intersection with Grand Avenue
  - (19) The Southwest corner of Valleyview Crescent at its intersection with Grand Avenue
  - (20) The Southwest corner of Clare Way at its intersection with Grand Avenue
  - (21) The Southwest corner of Helen Place at its intersection with Grand Avenue
  - (22) The Northeast corner of Grand Avenue at its intersection with Hillside Place.
4. The Council shall cause to be erected and maintained at the right hand side of every street intersection a stop or yield street, at a distance of approximately ten (10) feet from the point of intersection, an appropriate sign. Such sign shall be so placed that it will face traffic which is approaching the "stop" street or "yield" street.
  5. The provisions of the Vehicles Act shall apply to all traffic approaching and facing a stop sign or yield sign erected and maintained in accordance with the provision of Section 4.
  6. No person shall deface, damage, destroy or remove any sign or marker erected pursuant to this bylaw.
  7. Every person found guilty of an infraction of any provision of this bylaw shall be liable to the penalties provided in the General Penalty Bylaw of the Village of Buena Vista.
  8. Bylaws No. 2/93, 4/94, 6/94, 7/94, 9/94, 3/95, 5/96, and 2/98 are hereby repealed.
